Dave called the meeting to order at 6:33 p.m.

Dave R. – Approval of Minutes & Updates:

- Dave requested to approve the Minutes. Minutes approved.

Jeff – Pro Shop & Golf Course Updates:

- Grounds Crew has started to work on the bunkers with new sand; will finish in 2024.
- Portable lights went over very well; no issues reported. Will look to have a third light next year as a back-up.
  - Something for the Board to approve for 2024.
- Good feedback on cut for CC after the second round; everything worked out well.
- Signage went up to remind players to fix divots, ball marks and rake bunkers.
- Hoping that Golf Genius grandfathers us in at the \$3,500 rate for 2024.

Tim B. – Handicap and Rules Report

Aaron M. – Membership Report:

Steve M. – Communication Report

## Steve C. – Treasurer's Report:

- Current cash: \$24,625
- Projected cash at EOY is \$9,500, about \$1,300 higher than last month.
- Forecast reflects decrease to trophy budget reflecting engraved pint glasses; approximately a reduction of \$1,400.
- YTD total rounds: 4,248 thru end of August; 8% or 350 lower than 2022, due to weather.
- FY rounds projected to be at 5,700.
- Current month includes \$225 spent on lights and extension cords for putting contests.

## Scott R. – Tournament Chair:

- Ringers is up-to-date; Jeff will update through Sept. 9 & 10.
- There are three team Match Play events remaining; five on the individual side remaining.
- Scott and Jeff talked about CC; there are 14 players in E Flight combined in the last three years; two are playing this year.
- Sixty-six in total in the CC this year.
  - Eleven are in the Senior CC.
- Two players in E Flight; payout is top-3.
  - o Recommend \$100 for first
    - Reallocate the remaining funds; Scott R. and Steve C. will discuss where to reallocate funds.
    - Steve R. seconds the proposal; the Board is all in favor.
